

ALLERGEN RISK MANAGEMENT & RESPONSIBILITY

Special diets are an **extremely important** part of our catering provision.

To ensure our pupils with allergies and intolerances can eat safely with us, Chartwells:

- **Has a dedicated team of special diets nutritionists**
- **Follow a strict special diet procedure, adhering to Compass Group's Health and Safety policy**

To minimise allergy risk, however, it is vitally important that **all** parties involved in the catering process take responsibility for ensuring correct procedure is followed.



ALLERGEN RISK MANAGEMENT & RESPONSIBILITY

As part of Chartwells' special diet procedure, Chartwells will:

- **Produce special diet menus** where possible, including our **Allergy Aware** menu, which safely covers any of the 14 EU allergens.
- **Provide allergy reports** for every recipe on our menu cycle.
- **Require medical evidence** of any special dietary requirement, to provide full transparency in case of an emergency.
- **Provide allergy training to frontline teams.** From our initial employee induction training to our monthly 'Allergy Academies', run by a special diet nutritionist; allergy training is continuous at Chartwells. 1:1 site visits from one of our nutritionists may also be arranged when extra focus is required.
- **Continue to raise awareness** of special diets and allergy risk within Chartwells, for example with allergy awareness campaigns.
- **Assist schools to identify pupils with special dietary requirements at school mealtimes** via our 'Hello my name is...' photo-sheets and special diet lanyards (optional).
- Be responsible for allergen management and information **to the point of service.**

In order to minimise allergy risk it remains our customer's responsibility to:

- **Inform Chartwells about any special dietary requirements**, including the necessary medical evidence and photos (where agreed), as per Chartwells' special diet procedure.
- **Keep Chartwells informed about any changes** to special dietary requirements or new pupils and communicate with parents to ensure clarity over any special diet agreements.
- **Use our allergen reports** to determine allergens in our products when required.
- **Ensure staff are aware of all special dietary requirements** and manage risk from point of service.


Hello my name is...

At Chartwells we launched ‘**Hello my name is...**’ because we want children to be recognised by their name and not just for their special diet requirements.

The ‘Hello my name is...’ scheme is designed **to ensure Chartwells’ catering staff can identify children following a special diet menu** when they come to the counter.

How does it work?

- School/parent submits special diet request form with medical evidence and child’s photo
- Special diet request is accepted and a special diet menu is put in place for the child
- Chartwells produce a ‘Hello my name is...’ poster with the child’s name, special dietary requirements and photo which is displayed (out of public view) behind the counter
- Chartwells produce a special diet lanyard (optional) for the child to wear during the meal service to aid with identification and assist school assistants in the lunch hall
- School arrange for the child to meet with the Chartwells’ unit staff to introduce themselves and say ‘hello, my name is...’ ahead of the first meal service for that child.
